## 2024 Golf Camp

The 2024 Owl's Nest Golf Camp is designed for boys & girls between the ages of 12-18. The teaching staff will provide golfers with quality instruction to improve their golf skills and allow junior players to elevate their game to the next level. The Owl's Nest Golf Camp will be a week-long camp that will run from Monday, July 29th to Friday, August 2nd.

Golfers will begin each day with instruction focused on a specific area of the game, working on performing those skills, and finish the day with a 9-hole round of golf.

**Requirements: Golfers will be expected to know the game of golf, have played multiple rounds of golf, know the fundamentals & etiquette, as well as being able to walk 9 holes.**
